The Issuer's gaming and casino revenues in Nicaragua and Guatemala have increased over the past few months, creating another record month in revenue for the Issuer. During the month of June 2007 in Guatemala the



operations generated revenue of \$343,000; in Nicaragua the three operating casinos of which the Issuer owns 52.6% generated \$1,129,000; the Panama operations, of which the Issuer owns 50%, posted revenue of \$5,012,000; and in Costa Rica, of which the Issuer owns 50%, the operation generated \$2,300,000 of revenue. The Issuer's Eastbay Resort and Poro Point casinos in the Philippines where the Issuer controls 60% and 61% of the operations respectively, generated revenue of \$2,921,000.

2. Provide a general overview and discussion of the activities of management.

In Peru, the Company continues toward a closing on its acquisition of the Hoteles Las Americas chain of Hotels in the greater Lima area. The HLA chain is one of the largest chains in Lima with its 6 hotel properties representing an aggregate of 650 rooms. Thunderbird is currently evaluating the viability of placing casino operations in 4 of the 6 hotels.
